Dear Client:

Thank you for choosing us to assist you with your 2025 tax return. We are very appreciative of your business. This letter serves as our engagement letter between you and Accounting Consultants Inc. and outlines the nature and extent of our services and responsibilities. We depend on you to provide the information we need to prepare complete and accurate returns. Please feel free to drop off your information at any time, mail, or upload your documents to our secure portal.

Our services are not intended to determine whether you have filing requirements in any state taxing jurisdictions other than the one(s) you have informed us of. If you are required to file a tax return for another country besides the United States, you are responsible for complying with the tax filing requirements of any other country. You acknowledge and agree that we have no responsibility regarding those issues and that foreign filing obligations are not within the scope of this engagement.

Organizer: Please return the client organizer to us along with this signed engagement letter. By completing the organizer, you will contribute to the efficient preparation of your tax return. **Page 1** of the organizer needs to be completed to inform us of any changes to your filing status, dependents, address, phone numbers, and banking information. **Pages 2, 3, and 4** of the organizer serve as our questionnaire of important information needed to prepare your return. **Page 5** is your Personal Checklist. If we prepared your 2024 return, this page includes forms and items you had on your 2024 return. If you prefer, we can deliver a more detailed client organizer by mail, email, or through our secure client portal. We need your original documentation (Forms W2 and Forms 1099, etc.). Please do not staple your original documents.

Secure Client Portal: We have a secure client portal where tax documents can be stored and retrieved at your convenience. To register for our client portal, we will send you an email with an activation link to your individual account. After activating your login, you can upload or retrieve encrypted and/or password protected documents and files that we need to send to you or you need to send us.

If you have an existing portal account, your password has not changed. Please email Kaci at kaci@accountingconsultantsinc.net if you would like to join our secure portal. Please see our website for a link to our portal. The link is located under the client resources tab. We strongly urge our clients to take advantage of this service for its privacy protection and convenience. Upon completion of your tax return, an electronic copy can be uploaded to the portal for you to retrieve at any time.

Estimated Tax Payments: If you make estimated tax payments, your fourth and final 2025 payment is due **January 15, 2026**. Checks are made payable to the "United States Treasury" and mailed to the **Internal Revenue Service, P.O. Box 1300, Charlotte, NC 28201-1300 (For Tennessee Residents)** using Form 1040ES, by paying online with EFTPS (eftps.gov), or IRS Direct Pay (irs.gov/payments).

Timing: We ask you to allow a reasonable amount of time for us to prepare your return. The following dates are important to remember for bringing in your tax information for the **tax deadline of April 15, 2026**.

March 3, 2026- If you are a One-Member LLC/Sole Proprietor we need your tax information by this date to have sufficient time to prepare your tax return. If not received, an extension will need to be filed.

March 16, 2026 - We must have all your tax information by this date to complete your return by the deadline of April 15, 2026, otherwise it will be necessary to file an extension. The automatic extension is six months for those requesting additional time to file. Payment of the estimate of your tax liability should be made with the extension by **April 15, 2026** in order to alleviate any charges from the IRS for interest and penalties. **Please note that extensions are an estimate of your tax liability.** Any tax payment made after April 15, 2026 will be subject to interest and penalties. It is your responsibility to pay these charges to the IRS. Filing an extension is easy: it allows you more time to gather your tax documents, it isn't treated any differently by the IRS, and it ensures that we have ample time to review and complete your tax return.

Electronic Filing: For tax returns prepared by our firm, all individual tax returns will be electronically filed. If you wish to mail your tax return to the IRS, please provide us your reason for Form 8948, "Preparer Explanation for Not Filing Electronically." It is important that you review Form 8879 (authorization for us to e-file your return) and your tax return before signing. Once a return has been e-filed and accepted, an amended return would have to be filed to make any changes. Additional fees would apply for the preparation of an amended return.

All returns should be signed and returned to us by **April 13, 2026**, to ensure enough time to resolve any issues that might arise (i.e., the return is rejected). This is crucial for returns that are completed close to the April 15th deadline.

Foreign Financial Interests: Please note that any person or entity having a financial interest in or signature authority over bank accounts, securities, or other financial accounts with a value exceeding \$10,000 in a foreign country is required to report these holdings/relationships. Although there are some limited exceptions, filing requirements also apply to taxpayers that have direct or indirect control over a foreign or domestic entity with foreign financial accounts even if the taxpayer does not have foreign account(s). For example, a corporate-owned foreign account would require filings by the corporation and by the individual corporate officers with signature authority. Failure to disclose the required information to the IRS may result in substantial civil and/or criminal penalties. Please inform us if this applies to your situation.

Other Conditions of Our Engagement:

1. **Representation of Responsibility.** It is your responsibility to provide us with all the information necessary for the preparation of complete and accurate income tax returns. We will not verify the information you give us; however, we may ask for additional clarification of some information. Due to the imposition of certain penalties and interest for late filing of returns, you assume full responsibility for the timely filing and payment of all amounts due. Your returns are subject to examination by the taxing authorities. In the event of an audit, you may be requested to produce documents, records, or other evidence to substantiate the items of income and deduction shown on a tax return. If an examination occurs, we will represent you; however, these additional services are not included in our fee for preparation of your return. We will render additional invoices for the time and expenses incurred in representing you in an audit and responding to any IRS notices. We will return your original records to you at the end of the engagement unless you only provided us with copies. You should securely store these records, along with all supporting documents, receipts, canceled checks, etc., as these items may later be needed to prove accuracy and completeness of a return. We will retain copies of your records and our work papers for your engagement for seven years, after which these documents will be destroyed.

The law imposes penalties when taxpayers underestimate their tax liability. Should we encounter instances of unclear tax law or of potential conflicts in the interpretation of the law, we will outline the reasonable courses of action and the risks and consequences of each. We will ultimately adopt, on your behalf, the alternative you select. In preparing your returns, we will rely on your representations that we have been fully informed of all such transactions and that you have complied with the documentation requirements. You have the final responsibility for the income tax returns and therefore, you should review them carefully before you sign them.

2. **Authorization to Discuss.** The IRS permits you to authorize us to discuss, on a limited basis, aspects of your return for one year after the return's due date. Your consent to such a discussion is evidenced by checking a box on the return. Unless you tell us otherwise, we will check that box authorizing the IRS to discuss your return with us.
3. **Tax Return Preparation Fee.** Our invoices will be based on a fee per form or schedule. However, some tax returns require additional work which will be billed out at an hourly rate. **Payment for our invoice is due at the time you receive your return. A tax return will not be e-filed unless payment for our tax preparation services has been made.** Delinquent invoices will be subject to a late payment charge of 1.50% per month (18% per year) so please make payment upon delivery of your tax return to avoid any finance charges. We accept VISA, MasterCard, and Discover if you would like to pay by credit card.
4. **Agreement.** If the tax services and terms outlined above are in accordance with your understanding of our engagement, please **sign this letter in the space provided and return it with your tax information.** By signing this letter, you are also acknowledging that you have answered all questions on this organizer completely and accurately for the purposes of the preparation of your 2025 income tax return(s).
